**NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors hereby adopts Westwinds Village Policy for the Collection of Construction Debris, as a guide to the collection of construction debris for Westwinds Village shareholders.

# **Westwinds Village Policy for the Collection of Construction Debris**

### **Manatee County definition of Construction Debris:**

Construction / Demolition or C&D is defined as: Debris is non-mixed (no garbage) material resulting from construction, remodeling, repair, or demolition of structures. C&D disposal in Manatee County is an open market, which means businesses may utilize the County's contracted haulers, or any other available vendor.

These materials include (but are not limited) to the following:

- Bricks, concrete, and other masonry materials
- Soil (mixed with other C&D debris)
- Wood, including nonhazardous painted, treated, and coated wood and wood products
- Drywall
- Plumbing Fixtures
- Non-asbestos insulation
- Roofing shingles and other roof coverings
- Metal materials incidental to any of the materials above

### Westwinds Village Policy:

C&D will be picked up on the third Thursday of each month. Shareholders/residents must notify office that they have C&D to be picked up by 4:00pm on the third Tuesday of the month. Bagged and/or bundled C&D weighing less than 10 pounds will be picked up free of charge. C&D over 10 pounds and less than 150 pounds will be picked up for a fee of \$10. Fee must be paid at the office by 4:00pm on the third Tuesday of the month.

Each unit is allowed a maximum of 150 pounds of bagged and/or bundled C&D per month. Each bag and/or bundle may weigh a maximum of 50 pounds. Smaller bags and/or bundles are encouraged but must comply with the 150 pound limit. Materials must be cut to a maximum 4 feet in length. C&D in boxes or in pails will NOT be picked up. Household hazardous waste will not be picked up. C&D that has been registered at the office shall be placed at the curb on the third Wednesday of the month.

#### C&D greater than 150 pounds:

Debris greater than 150 pounds will not be picked up by Westwinds Village. Shareholders/residents must make alternative arrangements such as but not limited to:

- 1. Haul the C&D to the Manatee County Lena Rd. Landfill Site at 3333 Lena Rd, Bradenton, FL 34211
- 2. Waste Management Bagster 1-Count Green Outdoor Polypropylene Construction Trash Bag. Holds up to 3,300 pounds of debris. 8-ft x 4-ft x 2-ft 6-in.

3. Waste Management 20 Yard Roll-Off Dumpster. A 20-yard temporary roll-off dumpster can hold up to 8 pickup truck loads and is ideal for large attic, basement or garage cleanouts and kitchen or bathroom remodels.
